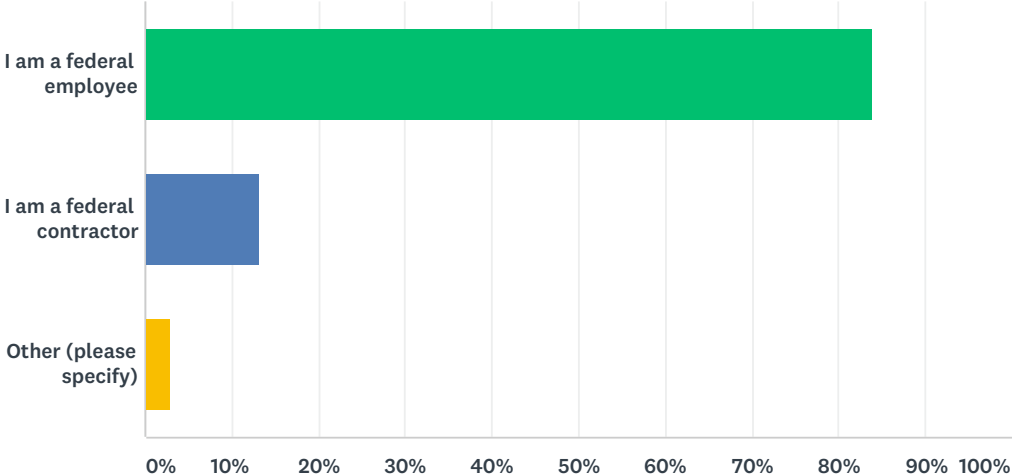


Q1 Are you a federal employee? Are you a federal contractor?

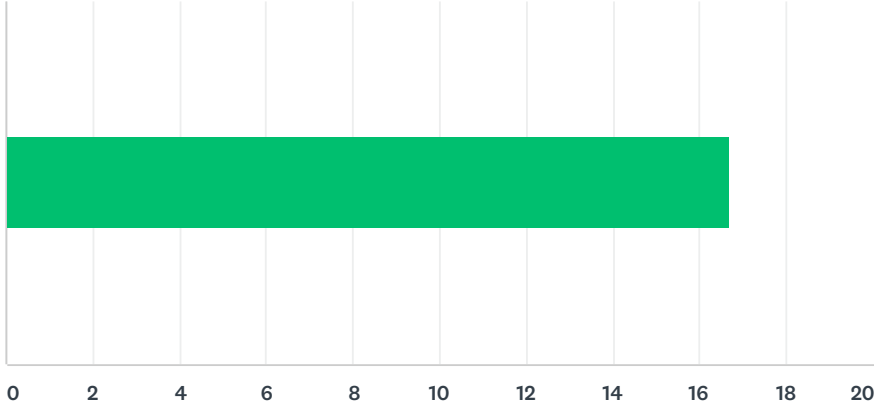

Q2 How long have you been working for the federal government?

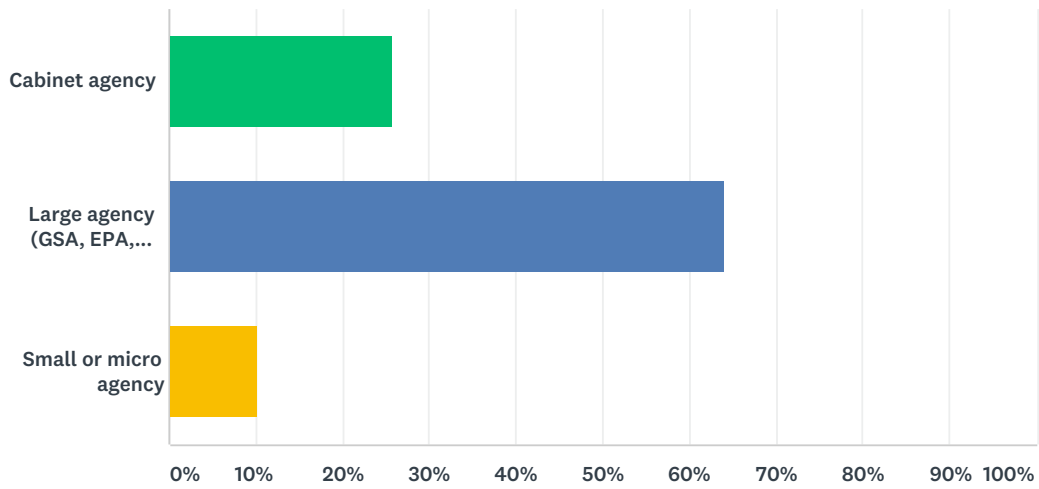

Q3 If you are a federal employee, what kind of federal agency do you work for?

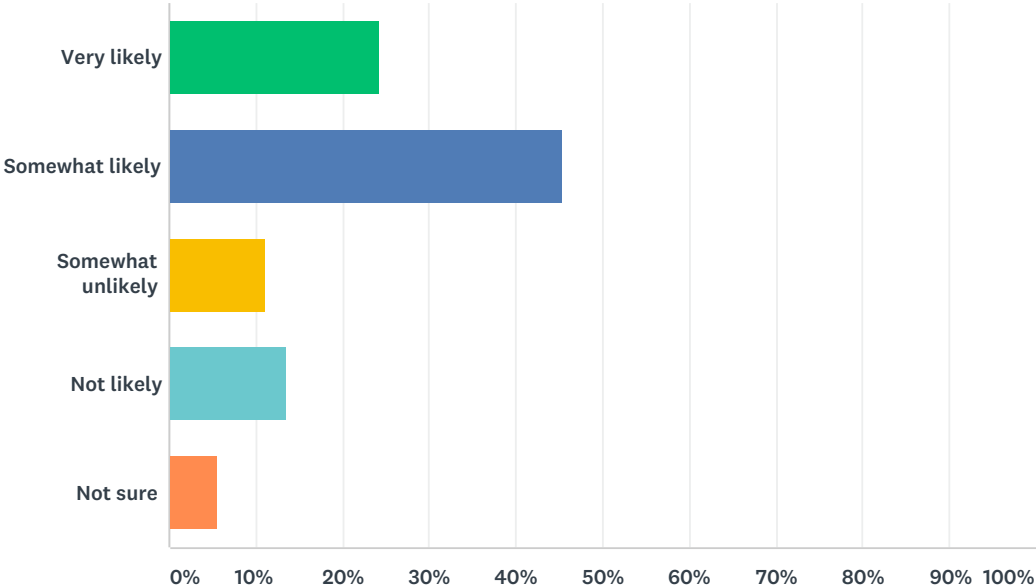

Q4 How likely do you think there will be a government shutdown on Jan. 20?

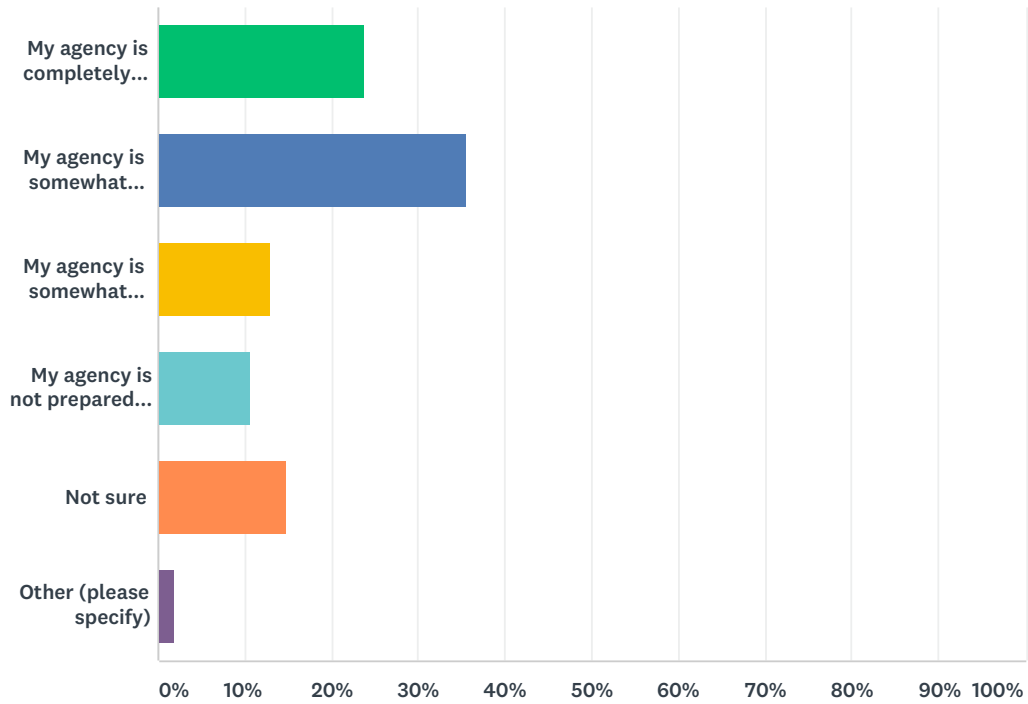

Q5 How would you rank your agency's shutdown preparedness?

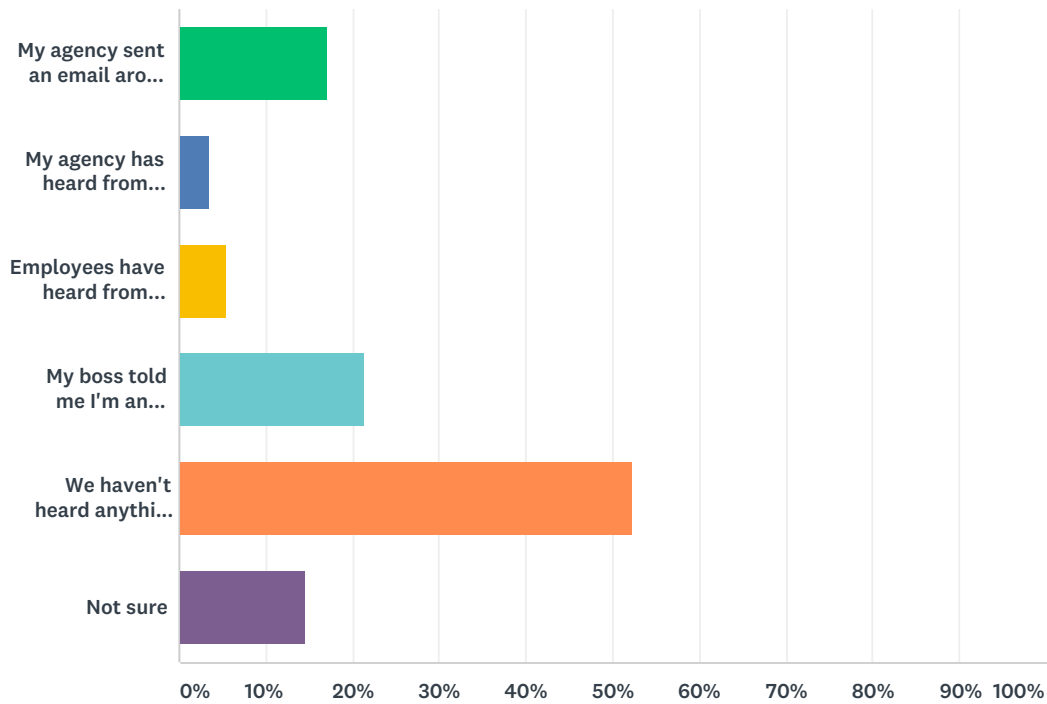

Q6 What steps has your agency taken to prepare for a potential shutdown? (Check all that apply)

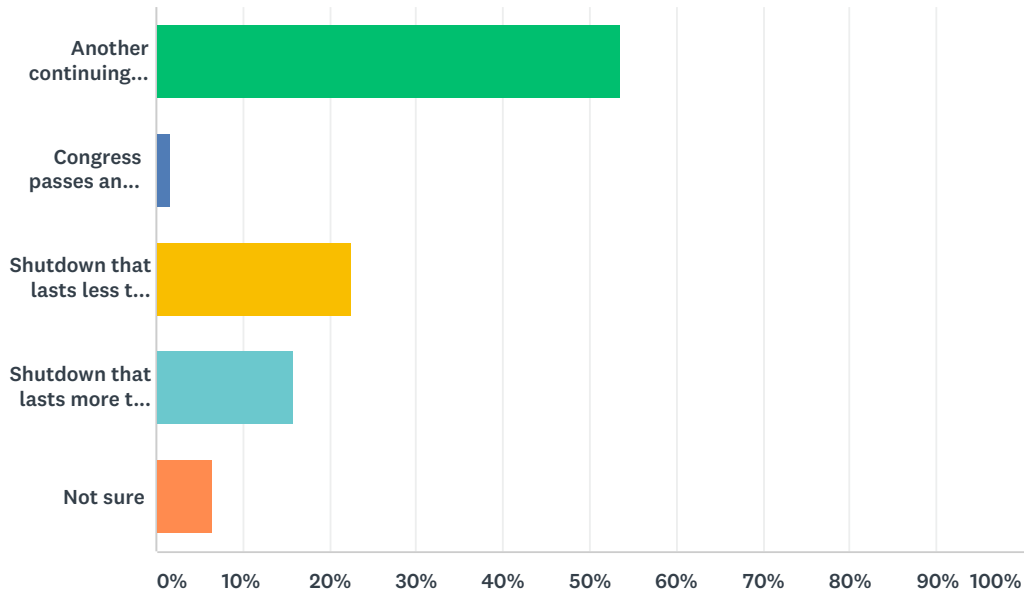

Q7 What do you think is the most likely to happen after the current continuing resolution expires?

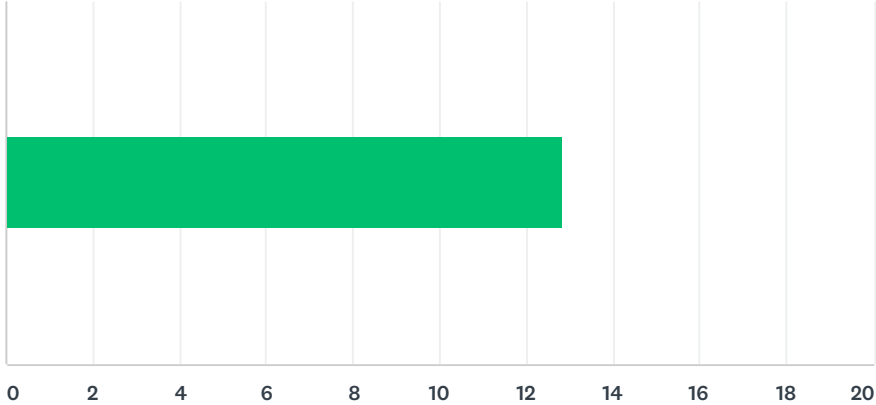

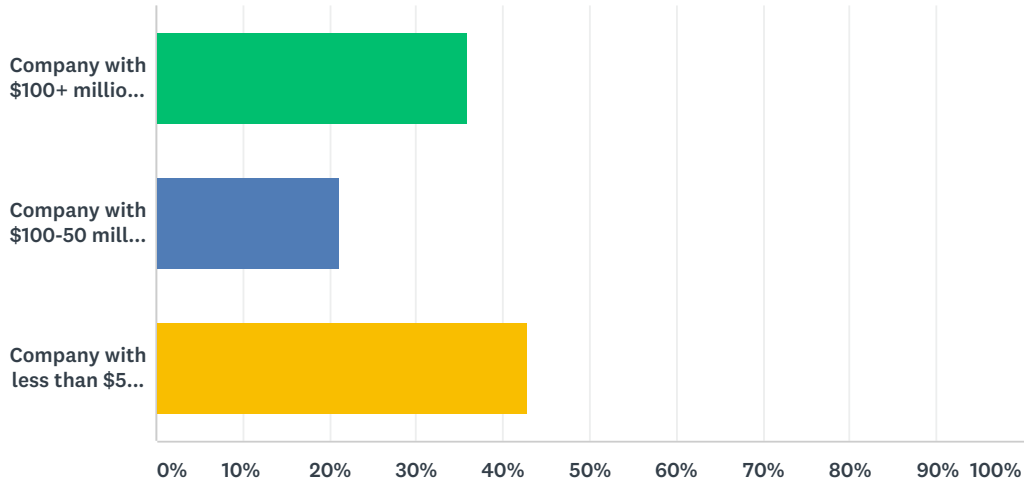

Q9 What size company do you work for?

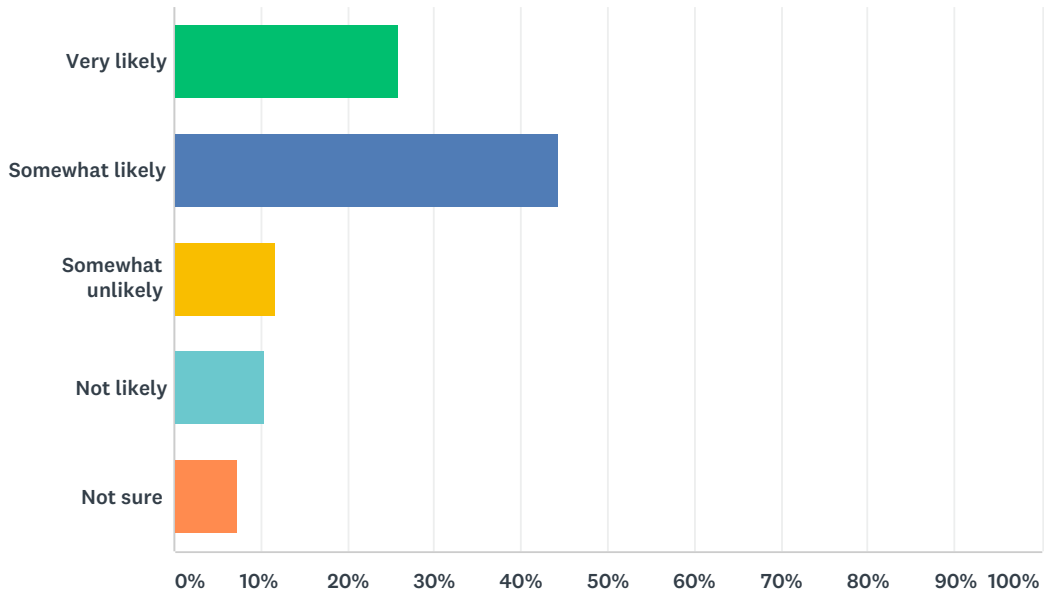

Q10 How likely do you think there will be a government shutdown on Jan. 20?

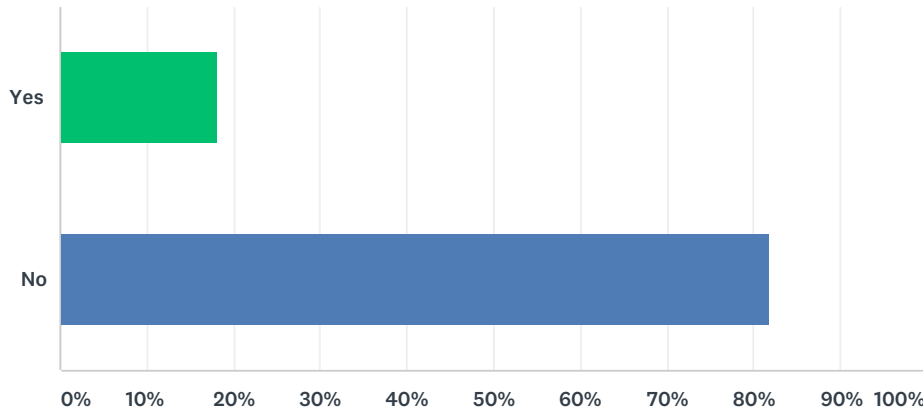

Q11 Has your agency customer(s) contacted you about a possible government shutdown? If yes, please elaborate.

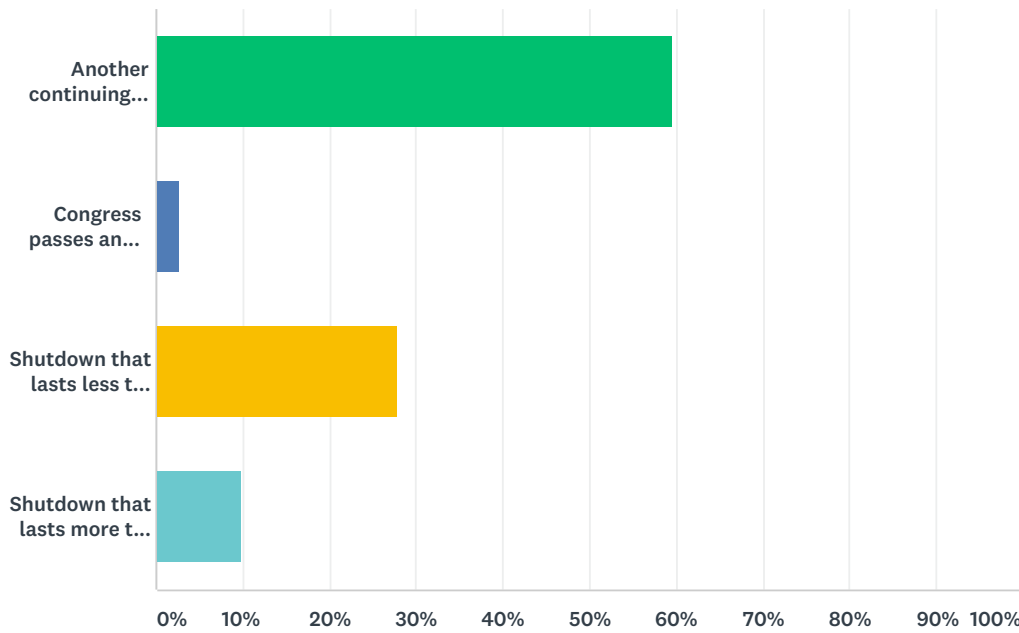
